Thereafter, the Company had provided additional information to Bursa Malaysia Securities Berhad on 9 October 2018 (Reference No. GA1-09102018-00066) in reference to the same.

The Board of Directors of TWPH wishes to announce that the Proposed Disposal has been completed on 19 November 2018 on receipt of the Deposit amounting to AUD2,201,888 (equivalent to approximately RM6,518,000) from Anzpac's agent, Colliers International (NSW) Pty Ltd and the Balance Sale Consideration amounting to AUD19,817,000 (equivalent to approximately RM58,658,000) from CEA. As such, Anzpac had received the full payment of the Sale Consideration of AUD22,018,888 (equivalent to approximately RM65,176,000) on 19 November 2018. All other terms and conditions of the Proposed Disposal remained unchanged.
