On 26 July 2018, IPS had on behalf of TWPH, submitted an application to seek Bursa Securities' approval for an extension of time ("**EOT**") from 3 August 2018 to 3 October 2018 to issue the Circular pending TWPH's intention to re-negotiate certain terms of the JVSA with its joint venture party. On 31 July 2018, Bursa Securities had approved the application for the EOT of two (2) months from 4 August 2018 to 3 October 2018 to dispatch the Circular pursuant to Paragraph 9.33(1)(b) of the MMLR.

On behalf of the Board, IPS wishes to announce that there will not be any change to be made to the terms of the JVSA arising from the re-negotiation between the Joint Venture Parties.
