The Board of Directors of New Toyo International Holdings Ltd (the “Company”) refers to the Company’s announcements made on 25<sup>th</sup> and 29<sup>th</sup> May 2015 and wishes to announce that its subsidiary, Tien Wah Press Holdings Berhad (“TWPH”), has today issued an announcement on the legal completion of its joint venture with DOFICO following its sale of 50% of Toyo (Viet) Paper Product Co. Ltd (“TVP”) to DOFICO (“Transaction”), a copy of which is enclosed (“TWPH Announcement”).

Following completion of the Transaction, TVP becomes a jointly controlled entity of TWPH. Likewise, TVP ceases to be a subsidiary and becomes a jointly controlled entity of the Company.

The TWPH Announcement also disclosed that TVP has changed its name to “Toyo (Viet) – DOFICO Print Packaging Company Limited” to better reflect the joint venture.

Interests of Directors and Controlling Shareholders

None of the directors or controlling shareholders of the Company have any interest, direct or indirect (other than through their shareholdings in the Company), in the change in TVP’s status from a subsidiary to a jointly controlled entity of the Company.

The Board of Directors of TWPH wishes to announce that the Joint Venture Agreement was legally completed on 5 May 2016 with the issuance of the Enterprise Registration Certificate for two members Company Limited by the lawful State Authority of Vietnam on 5 May 2016 and dated 29 April 2016 with regards to the disposal of 50% of Toyo (Viet) Paper Product Co. Ltd ("TVP") to DOFICO for total cash consideration of USD1,629,763 (equivalent to RM 7,012,137) as per the earlier announcement dated 25 May 2015 (sections 3.2 and 3.8 c(ii) of the aforesaid announcement refer).

TVP has also changed it's name to "TOYO (VIET) – DOFICO PRINT PACKAGING COMPANY LIMITED" to better reflect the joint venture.
